# Individuals from Economically Disadvantaged Families, Including Low-Income Youth and Adults

### **Defined:**

Economically Disadvantaged Families - Any individual or member of a family who receives need-based financial assistance, or whose income is at or below the poverty level as defined by the U.S. Department of Health and Human Services is considered an individual who is from an economically disadvantaged background.

Economically Disadvantaged Youth - A person 18-24 years old whose annual family income is at or below the income guidelines for Federal Free or Reduced Lunch Programs, and who has significant barriers to employment, as defined by the Federal Workforce Investment Act.

\*Nearly one-third of college students are lowincome, and most don't know the resources and programs that can help them.

\*Students from low-income communities are three times less likely to earn a postsecondary degree.

# **Access and Equity Considerations:**

- Students experiencing poverty may need more or different types of support to achieve the same outcomes as those with more economic resources.
- Integrated and holistic services and supports across three pillars: (1) employment and career advancement,
   (2) income and work supports, and (3) financial services and asset building.
- Changing college staff members' mindsets about students struggling with poverty and related challenges, as well as attitudes toward the colleges' role in addressing these issues
- Implement a Short-Term Enrichment Program (STEP) that pairs economically disadvantaged students with role models that help them with the development of education and career goals.
- Provide affordable living options and/or resources for students to find affordable living options near campus.
- Evaluate how Financial Aid eligibility rules hinder access to other assistance and ways to address and eliminate the barriers.
- Disadvantaged students often are under a lot of stress, so it's important to make the classroom a place where they can seek support and feel understood.
- Find effective ways to eliminate class one-time out-ofpocket costs that are only needed for the class and have no usefulness after the class is completed.
- Do not assume that economically disadvantaged students have the funding available to access technology or that I will have ongoing access to technology.

## **Program Examples:**

- Amarillo College No Excuses
- Circle of Support Community partnership so non-academic barriers such as emergency expenses, child care, transportation, housing, and food do not hinder students from academic success.
- PACE (Partners for Student Access, Collaboration, and Equitable Outcomes) – implementation of community liaison and student case manager for ease of access.
- PASS Program (Providing Academic Support to Students) Advising team that does case management and works with other programs to help with holistic support such as textbooks or childcare needs.
- Ranger Closet Clothes, Shoes, and Toiletries to assist students with the transition from education to careers (interviewing) and emergency needs where they have lost support.
- Social Services Benefits Navigator Individual that works with community partners and students to apply all available help and options holistically.
