Dr. Deana Savage and Suzy Barr



**Dr. Deana M. Savage** of Midland, Texas is Special Advisor to the President of Midland College where her responsibilities include serving as the College's Accreditation Liaison and overseeing the Department of Institutional Planning, Effectiveness and Research and the College's Student Success Initiative. Prior to serving in this capacity, Dr. Savage served as Associate Vice-President of Instruction for Career and Technical Programs. Dr. Savage has served as Committee Chair for SACSCOC Off-Site, On-Site and Substantive Change Committees. She has also participated for over six years on the SACSCOC Committee on Compliance and Reports (C & R) as a Special Reader. Much of this work has been on Group A, the body charged with

reviewing Substantive Change actions. Dr. Savage is currently a member of the Texas Workforce Education Leadership Committee and the Texas Programs of Study Steering Committee. Previously, she served as President of the Texas Association of College Texas Educators and President of the Texas Administrators of Continuing Education.



Suzy Barr is the Associate Vice President of Planning and Accreditation at Trident Technical College (TTC) in Charleston, South Carolina. TTC is a two-year college, offering both transfer and applied science degrees to approximately 18,000 students per semester. In her 30 years at TTC, Barr has served as a faculty member in mathematics, as the Assistant Vice President for Instruction, and for the past 11 years, as Associate Vice President. In addition to overseeing the college calendar, faculty credentials, the college's strategic plan, and the offices of IR and IE, Barr holds full responsibility for all SACSCOC-related projects and activities at the college. She directed TTC's last two reaffirmations of accreditation, has served on or chaired over 30 SACSCOC committees, and has participated for several years as a special reader

for the SACSCOC Committee on Compliance and Reports. She was a member of the SACS Peer Review Advisory Board for five years, and she received the SACS Meritorious Service Award in 2010.

When an accredited institution significantly modifies or expands its scope of operation or changes the nature of its affiliation or ownership, a substantive change occurs. This session will review the types of changes that are included in the Commission's substantive change policy, approval and notification requirements, and reporting timelines. Dr. Sáenz earned his Ph.D. in School Psychology from Texas A&M University. Donna Carlin is the Assistant Director for Community Colleges in the Workforce, Academic Affairs, and Research Division at the Texas Higher Education Coordinating Board. Her primary job is oversight of the Carl D. Perkins grant program. In addition, she been involved in monitoring legislation and rule development for the past three legislative sessions for the bacterial meningitis vaccination legislation. She's been a member of the Texas Center for Nursing Workforce Studies since 2006, which is a committee that publishes studies on the supply and demand projections for nursing in Texas, as well as hospital staffing and many other nursing studies. She's been employed at the Coordinating Board since 2000, and has participated in the writing of several

studies on nursing education, and a recent white paper on the Doctor of Nursing Practice. Prior to working at the Coordinating Board, she worked as a nursing consultant at the Texas Board of Nursing, taught nursing at West Texas A & M University, in Canyon, Texas, and worked for many years a critical care staff nurse. Ms. Carlin is a graduate of West Texas A & M University with a bachelor's and master's degree in nursing.

The latest information about the Carl D. Perkins grant program will be provided, including projected funding for the 2014-2015 grant year. An update on congressional efforts for the reauthorization of the Perkins Act will be presented, as well as the innovative ways reserve funding is being used to advance high quality CTE in the state.

Dr. Rex Peebles has 30 years of experience in higher education, including positions as instructor, professor, department head, dean, and vice president of instruction. He currently serves as the Assistant Commissioner of the Workforce, Academic Affairs, and Research division of the Texas Higher Education Coordinating Board. Dr. Peebles served six years as a member of the Undergraduate Education Advisory Committee, serving from 2010 to 2012 as the committee's co-chair. The Core Curriculum, applicable to all public colleges and universities in Texas was revised during that tenure. In 2010, he was the recipient of the Ray Williams Outstanding Leadership Award from the Texas Community College Instructional Administrators (TCCIA). He served as a co-chair of the LEAP Texas Task Force prior to coming to the Coordinating Board. He has a Bachelor of Arts in

Political Science from The University of Texas at Dallas, a Master's in Political Science from The University of Texas at Arlington, and his Ph.D. in Government from The University of Texas at Austin. He has co-authored a Texas state and local government textbook, Texas Politics and Government: Ideas, Institutions, and Policies and authored The Theoria and Praxis of Obligations to Future Generations.

Senate Bill 497, passed by the 83<sup>rd</sup> Legislature, requires that by Fall 2015 all associate degrees be limited to 60 semester credit hours. Allowances for exceeding the 60 SCH limit can be granted when a compelling academic reason exists. In this session, Dr. Peebles will discuss the 60 SCH limit, what could be considered a compelling academic reason and the process to apply for an exemption to this rule.

### "Detailed occupational skill & learning outcome alignment: phase II fully automated" (Capital Ballroom A)

TSTC Waco proposes a Third and Final Year follow-up Perkins State Leadership project that fully validates the newly automated curriculum alignment system, SOA, and expands its use with additional technical programs at two-year community colleges across the state. For year three, TSTC Waco has selected 18 non-duplicated programs, with 36 Occupational Areas, which have demonstrated active advisory board members for curriculum alignment and revision from and among twelve two-year (non-TSTC) colleges. Virtual advisory board members serving as key subject matter experts will receive complete information necessary through an online web-based survey for their fine tuning during the virtual industry advisory process. Also for year three, TSTC Waco will work to fine tune the automated systems for collecting and matching data from the TWC's DWA database and the WECM database electronically. (For the 2011-12 grant and the 2012-2013 grant, the raw data used for the goodness-of-fit and gap analysis had to be manipulated by hand in order to refine the curriculum for twenty-one different occupational areas.) The intense interest expressed by THECB and educators around the state at various presentations over the past two years attests to the importance of the Curriculum Alignment virtual industry advisory process at a time when colleges are working to ensure that their training programs meet industry needs. TSTC planned a robust recruitment effort in order to engage a geographical variety of colleges with a wide range of enrollments to participate in the curriculum alignment process for this proposed grant year. Going forward, all Texas two-year colleges will now be able to rapidly input their essential curriculum elements into the online SOA system and in short order receive a comprehensive review for their program as to its relative match to the needs of the employers that hire their graduates. Furthermore, using the SOA public site, previously analyzed programs will be available online for two-year colleges with similar programs to easily compare the DWAs of the completed programs with the DWAs of their own programs and for a comparison-to-fit for their employers.

#### "Programs of Study, a wave to ride" (Congress)

The Programs of Study Perkins Funded Project extends the work completed during the Dallas

County Community College District, TEA and Texas Tech to align AchieveTexas' Program of Study (POS) with College and Career Readiness Standards (CCRS), and the Tarrant County College District Energy Career Cluster Pathway model. Using outcomes and challenges from these projects, San Jacinto Community College is developing a strategic plan for State Programs of Study (POS. The long-term goal is to Integrate Programs of Study (POS) into career and technical education programs, and to align the Program of Study (POS) development process with the efforts of other state agencies. The presentation will focus on the 2014 project activities for developing State Programs of Study and their linkage to the WECM course writing manual.

Austin Community College Biotechnology Program received a Perkins Leadership Award to develop a Biotechnology Network in Texas where community colleges support high school biotechnology efforts. The network will provide biotechnology training and equipment to high school teachers for the purpose of recruiting students to biotechnology and STEM careers. Come learn how this network is being established to meet the growing employee needs of the Biotechnology Industry in Texas while also, provide students with dual credit for taking the high school Advanced Biotechnology. This course is equivalent to a college-level, common core Biology course.

#### "College opportunities for veterans" (Capital Ballroom B)

Dallas County Community College District (DCCCD) recently received a \$150,000 grant from the Texas Workforce Commission; the grant is enabling the district to create a Veterans and Service

members accelerated career paths for industry certification in information technology and an optional Internet marketing specialist certificate. The program is offered at all seven colleges in the DCCCD system, reduces the time Veterans and Service members needs to complete an associate degree and certificate for those specified areas. Service members and veterans who had computer information technology training during their tour of duty can receive credit for that education and experience through DCCCD's College Credit for Heroes program. The primary goal is to provide college credit for these courses – beginning with the 2014 spring semester – to decrease the amount of time a student takes to earn an associate degree in IT or a workforce IT certificate so that veterans can transition into the workforce quickly. DCCCD will help meet the workforce needs in Dallas County.

#### "Marketing...new ideas and a fresh take for any budget" (Austin South)

The commercial featured 2 kids who didn't know if they would like the cereal or not, they decided to get Mikey to eat it because "Mikey will eat anything." I am the Mikey of Chick-fil-A because I will try anything. Amazingly, I am also slow enough that I may try it 2 or 3 times before I give it up. Sometimes it's a bust, sometimes it's a MAJOR bust. But sometimes it's a success. Sometimes even a GREAT success. In 2008 I made Ripley Believe It or Not for the world's largest handspun milkshake. I made the world's largest lemonade in 2009. And in 2010 we set a new record for 1140 gallon sweet tea. The first Chick-fil-A store I owned only did \$286,000 in sales my first year. Today I do almost twice that each month at one of my locations.

In selecting training programs for redesign through a Department of Labor TAACCCT Grant, Amarillo College turned to local employers for advice. The employer community helped identify the training programs to target and have continued to provide input related to the skills job applicants should possess – both the technical skills and the more general workplace success skills, or "soft skills." Plans are in place for ongoing employer involvement in evaluating the redesigned curriculum and assessing whether students who have completed the redesigned programs are better prepared for the workplace than previous job applicants.

"Fusing math into welding: designing a contextualized course for welders" (Capital Ballroom A) The presentation will demonstrate a model of instruction which combines mathematical and welding concepts to build critical thinking skills in developmental mathematics learners which can be directly applied to their career field of welding. The purpose of the demonstration is two-fold: First, to provide instructors with a feasible course design option which allows welding technology certificate and degree prospects the opportunity to complete their developmental math requirements while simultaneously completing the requirements for a certificate or degree, and second, to explain how to design a hands-on contextualized course which will help to ensure that certificate holders and graduates of the Welding Technology program are proficient in mathematics and hence, well prepared for a job in the welding industry.


